a manner consistent with world-class standards of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances; That Client/Organizer shall keep MEC free and harmless against losses, claims, demands, liabilities, actions and expenses, including legal fees, arising out of or in connection with any catering service and/or food selling activities by the appointed Non-Accredited Caterer/Food Provider.

7. This Release and Waiver of Claims is being executed in compliance with the requirements of MEC.
